### ACCEPTABLE PROOF OF AGE DOCUMENTS:

- ✓ *Birth certificate*
- ✓ *Valid Canadian passport*
- ✓ *Citizenship card or permanent resident card*
- ✓ *Valid NEXUS card*
- ✓ *Valid driver's licence*

### NAME CHANGE DOCUMENT:

If your *proof of age document* does not show your current name, you must also provide any *name change documentation* (such as a *marriage certificate*).

### PROOF OF EMPLOYMENT\* EXAMPLE DOCUMENTS:

- ✓ *T4 – Statement of remuneration paid*
- ✓ *Pay slips*
- ✓ *Cheque stubs*
- ✓ *Record of employment*
- ✓ *Employment verification letter*
- ✓ *Notice of assessment*

\*Please note, employers must have participated in the IWA–Forest Industry Pension Plan at the time of your employment.
